



## **Bloomington Police Department Multicultural Advisory Committee**

The Joint Community Police Partnership (JCPP) is a joint project between Hennepin County and the cities of Bloomington, Brooklyn Center, Brooklyn Park, Crystal, Hopkins, New Hope, Robbinsdale, Edina, and Richfield. The mission of the JCPP is to enhance communication and understanding between law enforcement agencies and multicultural residents of the city. We are working together to build safer communities.

As a core component of the JCPP, the Multicultural Advisory Committee (MAC) advises the Bloomington Police Department on how to better serve, communicate with, and understand the community. The MAC meets monthly with BPD personnel to discuss topics that are important to their communities, and to open up two-way communication. The primary role of MAC members is to highlight community concerns and work strategically and collaboratively with the community and the BPD to address those concerns. The MAC also co-organizes many community engagement initiatives. MAC members come from diverse cultural, professional, and educational backgrounds, and serve as ambassadors to the communities and organizations they represent.

The JCPP welcomes your application for a position on the MAC, serving the communities of Bloomington and the Bloomington Police Department. We seek members who:

- Live, work or worship in Bloomington, or have some other significant connection to the city;
- Are able to attend monthly meetings: last Wednesday of every month, 6:00pm-8:30pm;
- Embrace the diversity of our community;
- Are willing and eager to participate in challenging and meaningful conversations;
- Can act as a bridge between the community and police department; and,
- Will work collaboratively to enhance relationships between police and the community, specifically with immigrants, communities of color, and other underrepresented communities in Bloomington.
