Veh 1 was turning left from a West to East throughway. Veh 1 then completed left turn North into the parking lot through lane. As Veh 1 was turning, the driver ran over the pedestrian trapping the pedestrian under the vehicle. Police and Fire responded and freed the pedestrian. The pedestrian had injuries ranging from head trauma to a possible hip fracture.

Veh 1 driver was not under the influence, but was making statements that would tend to show she was having a paranoia episode. Veh 1 driver made comments that people were out to get her. I asked her if the pedestrian was trying to get her and she stated "she didn't know, but people stalk me all the time and there is a gps in my car that THEY put in there."

I do not believe there was any intent for the Veh 1 driver to deliberately run over the pedestrian. Veh 1 driver has a IA DL and the vehicle is registered out of Wyoming. She is currently staying at the Dorthy Day Center. She couldn't tell me if her insurance was active but stated it was through State Farm.

Veh 1 was impounded and brought to BPD evidence garage awaiting further investigation.
