On 06/11/2024 I Officer Barnum responded to the intersection of American Blvd E. and Portland Ave S. for a motor vehicle hit and run.

Upon arrival, I met with veh 2 who stated that they were stopped at the intersection of Portland Ave S and American Blvd E. stopped at the stoplight facing north bound when veh 1 struck the back of vehicle 2.

After being stuck, veh 2 got out and attempted to get insurance information and a drivers license from veh 1. Veh 1 stated that it was not their vehicle and they did not have a drivers license on their person. At this time, veh 1 drove away without providing any information.

Veh 2 was able to get the license plate from veh 1 and a description of what the suspect looked like.

Veh 2 had two minor scratches on the back bumper and it is unknown what veh 1 had for damage due to them driving off.

No injuries to vehicle 2.

#310 Update. Spoke with R/O who stated his friend was driving his vehicle at the time of the incident and claimed that the Victim stated they were good with only damage to the license plate. The friend was not identified.

On 6/12/2024, at approximately 1828 hours, Bloomington officers were dispatched to a two-vehicle crash with injuries at 90th/Portland.

Upon arrival, I observed two vehicles facing southeast, both on the sidewalk of the south east portion of 90/Portland. The cars were touching each other. Both vehicles had heavy front-end damage, and engine fluids leaked from them.

I made contact with the driver of vehicle 1, a Jeep SUV. She appeared to be in significant pain, unable to put weight on her feet. She exited the Jeep from the passenger side. They reported traveling eastbound on 90th Street, had a green light, entered the intersection of 90th/Portland, and were impacted by the other vehicle. She thought the other vehicle was traveling westbound 90th and attempting to turn left to southbound Portland. She was the sole occupant of the car. The driver was transported to Fairview Southdale by Allina, run # 242422587. The driver had a possible leg injury.

I made contact with the driver of vehicle 2. While speaking with him, he claimed that his leg was broken. I attempted to feel for a break but did not feel any bones protruding and did not see any blood. The driver of vehicle 2 claimed to be in significant pain and was transported by Allina to Fairview Southdale, run #242422585, for a possible broken leg. He was not able to provide proof of insurance on the scene. DVS shows the driver of vehicle 2 did not have a valid driver's license.

In vehicle 2, I observed purchase agreement papers in the Affordable Auto Sales Group glove box dated 05/16/2024. The driver's signature was on the agreement to provide an insurance document. No mention of an insurance policy was listed.

Hours later, I tried calling the driver of vehicle 2. His phone went to voice mail and was not set up to leave a message. I sent a text message for him to send insurance info; at this time, he has not done so. A citation for various offenses will be mailed to him.

Witness 1, who was at the red light facing southbound on Portland, said she was waiting to cross 90th and was certain that her light was red, but could not provide any solid details on the crash.

Witness 2 Stated they were driving east bound 90th Street and set up to make left hand turn. White jeep was set up to make left hand turn to go SB Portland Ave from 90th Street. Tan jeep was then driving EB 90th Street and struck White jeep. Both had green lights.

Unit 1 turned left to go south on Aldrich Ave S in front of unit 2, causing a collision of unit 2's front right passenger side to the middle-rear passenger side of unit 1.

Passenger in front seat of unit 2 had minor injuries and would go to a hospital the next day. Evaluated on scene by Allina.

Driver of unit 1 was met at his house and evaluated for DWI, determined to be intoxicated and cancelled IPS. Driver of unit 1 was arrested for CVO, 3rd degree DWI, driving after DAC IPS, and no proof of insurance.

Damage on both vehicles was photographed and uploaded to Axon.

On the listed date and time, Veh 2 (Dump truck) was making a wide right hand turn to go south on Meadowview RD from eastbound E Old Shakopee RD., into the contraction zone.

Driver of veh 2, stated he activated his yellow emergency lights and right hand turn signal well before making the right turn.

Driver of veh 2 stated he needed to conduct a wide right hand turn due to the construction area layout.

Veh 2 was in the left hand lane and began to make the right hand turn. Lanes were clear and veh 2 began the turn, crossing over the right hand lane, and was struck by veh 1.

Veh 1 driver stated she was behind veh 2 in the left hand lane when it began to slow to conduct a right hand turn (unaware to her).

Driver of veh 1 stated she then went around veh 2 due to it slowing.

Veh 2 began to come into her lane (right lane) during its turn and she struck the front of veh 2.

No apparent injuries.

Veh 2 had very minor damage and veh 1 was towed due to damage.
