Driver of unit 1 was approaching the intersections of 78th and 12th in the far right lane. As she passed the entrance to the Holiday Inn of 12th heading NB, a male ran out from the west side of the roadway in front of her vehicle. She attempted to swerve to the left to avoid hitting him, but hit him with the front passenger side of the vehicle. The pedestrian was knocked forward onto the ground and was laying face down in the roadway.

The driver exited her vehicle to check on the pedestrian who got up and walked away. The pedestrian was located with a large welt on his head and apparent memory issues. He PBT's at a .030. He was sent on a transport hold due to a suspected head injury.

Driver of unit 1 provided an expired insurance card, but stated that it is up to date and the policy number is the same. There was no damage to Unit 1.

On 07/06/24 at approximately 0924 hours, Officers were dispatched to the intersection of 84th Street West and Xerxes Ave South for a two vehicle crash with possible injuries. Upon arrival, I spoke with Witness #1 who stated he was walking near the intersection when he saw the accident occur. Witness #1 stated he did not know who had the green light, but saw Unit #1 T-bone Unit #2 in the middle of the intersection. Unit #1 then went flying into the air and landed on the sidewalk crashing into the cement paver wall. Unit #2 was stopped in the middle of 84th Street facing West, on the West side of Xerxes Ave. Unit #1 was traveling West on 84th Street W. approaching Xerxes Ave S. and stated that it all happened so fast that she does not clearly remember if she had the green light or may have just missed it. Unit #2 was traveling North on Xerxes Ave S., to turn Westbound on 84th Street W. and did not see Unit #1 coming into the intersection. Unit #1 had minor injuries to her neck from the seatbelt and a small bruise to her left cheek. Unit #1 was transported to the hospital and vehicle was towed. Unit #2 and passenger did not need any medical attention and drove home from the scene.
