On October 21, 2024, at approximately 2001 hours, I, Officer Hanson #405, was dispatched to a crash with injuries at 102nd St W/Lyndale Ave S. Dispatch advised one female was injured.

Upon arrival, I observed two females sitting on the curb, one crying. One of the females identified as the driver was Brenda Rojas Guitierrez, driving a vehicle bearing Minnesota #JTB508. Brenda told me she was traveling southbound Lyndale when she turned left to travel eastbound 102nd. Brenda confirmed she hit a pedestrian with her car. Brenda denied needing medical attention, and I observed no visible damage to the front of her car. Brenda thought the pedestrian was walking within the crosswalk and said she did not see her.

I spoke with the pedestrian, identified as Ruth Habtamu. Ruth told me she had pain in her back and did not want an ambulance. Bloomington Fire Department arrived on the scene to assess any injuries; Ruth denied wanting Allina to respond and chose to have family transport her to Abbott Northwestern Hospital. It should be noted Ruth was wearing black pants and a black top, and the sun had set, and it was dark out. I did not see any visible injuries. I learned that Ruth was trying to cross 102nd Street using the crosswalk. I provided Ruth with my business card and urged her to call the police department and update me if the hospital discovered any injuries.

At 10/24/2024 0755 hours, Unit 1 and Unit 2 were driving eastbound on 98th Street about 20 feet away from the intersection on 98th Street E/Portland Ave S. Unit 1 was in lane 2 (far curb side). Unit 2 was in lane 1.

Unit 2 was unaware of unit 1, and merged into lane 1. Unit 2 hit the side of unit 1, leaving a small dent/scrape on the side of the passenger rear door all the way to the wheel well. Unit 1 failed to yield to Unit 2 and Unit 2 had nowhere to go without going into oncoming traffic if they had not collided with Unit 1.

Shortly after, both parties pulled to lane 2 and exchanged information. Photos taken and no injuries reported. Unit 2 was a transport system for a disabled child to get to school. All parties given the BPD report number.

Unit 1 was southbound on Bloomington Ave S at the intersection with American Blvd East. Unit 1 driver said he was looking to the east to see if traffic was clear before he turned westbound. Unit 1 said he did not look west as he would not be crossing westbound traffic. Unit 1 said he let his foot off the brake and started to move forward when he collided with the bicyclist at the front of his car. Unit 1 driver said he did not hit the accelerator prior to colliding with the bicyclist.

Bicyclist advised he was eastbound on the sidewalk and saw Unit 1 traveling southbound and looking left. Bicyclist said Unit 1 driver then accelerated and struck him on his bike. bicyclist had minor injuries to his left leg and left arm. Bicyclist was a juvenile and mother was contacted. Mother arrived on scene and it was determined she would transport the bicyclist for any medical care and declined ambulance care who was on scene.

No witnesses on scene, no dash camera on Unit 1 and no known video of the crash.

Unit 1 was warned for failing to yield to the right of way.
