On 04/02/2025 Officers were called to an accident.

Upon arrival I made contact with the drivers of both Unit 1 and Unit 2.

Driver of Unit 1, who is at fault, stated that she was exiting the Sams Club parking lot to go eastbound onto American Blvd.

Driver of Unit 2, was traveling westbound on American Blvd, with the right of way.

Unit 1 pulled out in front of Unit 2. Unit 2 collided with Unit 1 on the driver side.

Airbags were deployed. Driver of Unit 1 was evaluated by Allina due to the powder from the airbags, but was ultimately not transported.

Driver of Unit 1 was cited for failing to yield the right of way.

No further information at this time.

Unit 1 was traveling westbound on 98th St W approaching the intersection of France Ave S. Unit 2 was facing southbound at the stop light for France Ave S. Unit 1 had a red light but continued into the intersection. Unit 2 had a green light and proceeded into the intersection. Unit 1 hit Unit 2 on the drivers side front bumper. Unit 1 had airbags deployed.

A witness stated she was behind Unit 2 facing southbound on France Ave. S. and there was a car ahead of Unit 2. The light for southbound traffic turned green and the car ahead of Unit 2 drove through the intersection. As Unit 2 proceeded into the intersection, Unit 1 who was driving westbound drove into the intersection also and collided with Unit 2.

Single Vehicle Crash:

Vehicle was traveling west bound on 110th Street West when it left the roadway for an unknown reason striking a telephone pole near 10949 Drew (pole owned by Xcel Energy). The pole had about a 15 foot section broken off. The vehicle continued west crossing to the south back over 110th St. W where it went into the yard of 11000 Ewing Ave south. The vehicle went into that yard running through a chain link fence and then entered the yard of 11001 France where it went through a white plastic fence. The vehicle then went back to the north over a rock wall (2feet), then over a sidewalk where it rolled over onto its driver's side door facing southwest in the east bound lane of 110th St. W.

The driver had a very minor injury to a finger and said he was otherwise not injured. The driver said that he must have blacked out / passed out because he didn't remember the crash. He said that someone may have entered the roadway causing him to leave the road but he couldn't remember. He said that he did spill some of his coffee just before but remembered up righting it. He didn't know what happened.

The driver was conscious and talking when officers arrived and appeared pale but was able to communicate well.

The driver refused medics to check him out.

There were no signs of alcohol or drug use and the driver denied any usage.

The vehicle had significant damage all around and was privately towed by Chiefs.

Photographs were taken.

Case cards were provided to the driver, Excel and the two homeowners who had significant damage to their yards and fences.
