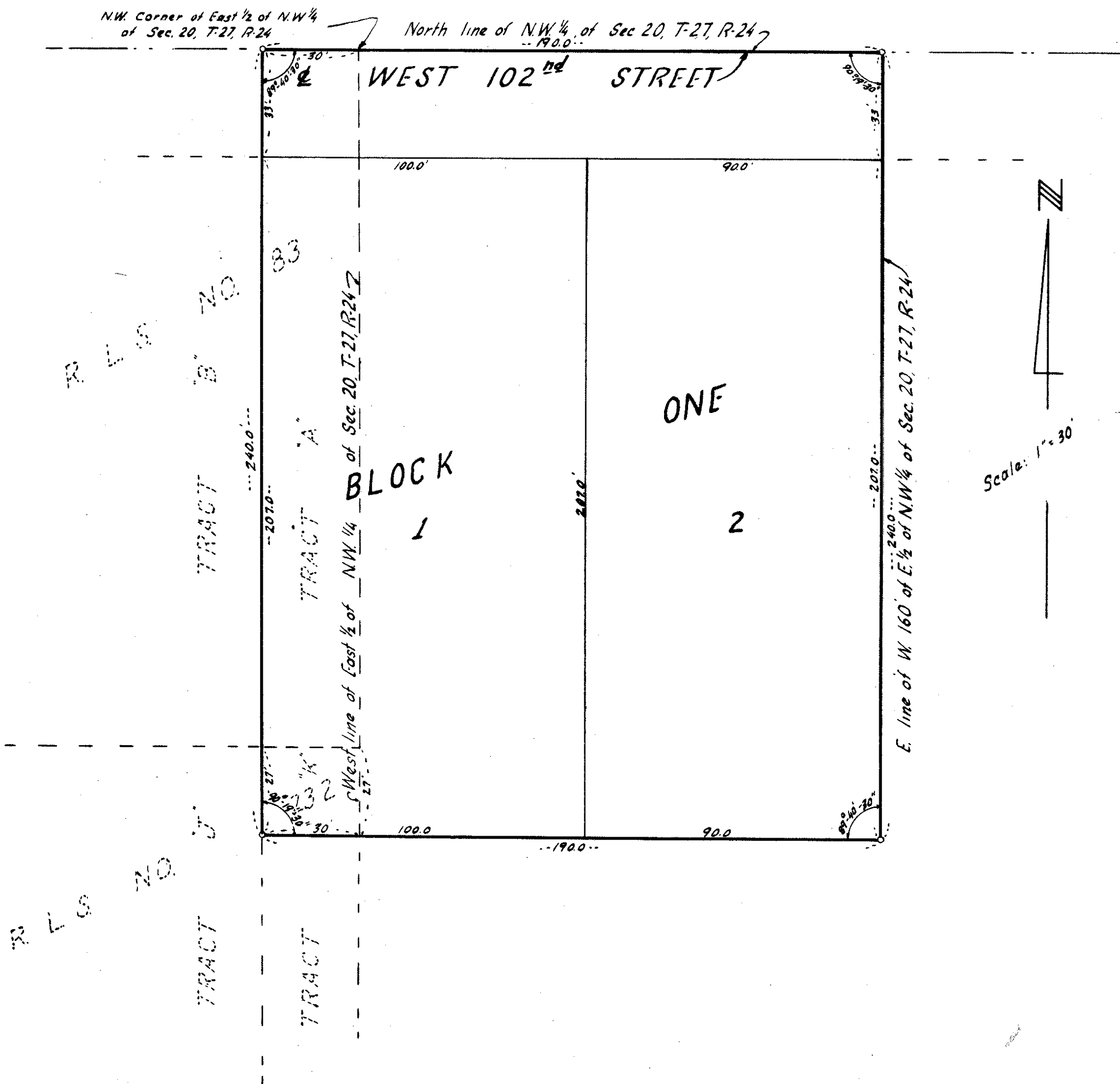

KNOW ALL MEN BY THESE PRESENTS: that Elwood B. Davis and Martha A. Davis, Husband and Wife, Owners and Proprietors of the following described property situate in the State of Minnesota and County of Hennepin to wit:

The West 160 feet of the North 240 feet of that part of the East one-half (1/2) of the Northwest Quarter (1/4) of Section Numbered Twenty(20), Township Numbered Twenty-seven (27), Range Numbered Twenty-four (24), described as follows: Beginning at the Northwest corner of the East one-half (1/2) of the Northwest Quarter (1/4) of Section Numbered Twenty (20); thence East Three Hundred Nine (309) feet; thence South parallel with the West line of said East one-half (1/2) of the Northwest Quarter (1/4) of said Section Numbered Twenty (20) a distance of Thirteen Hundred Forty-eight and six-tenths (1348.6) feet to the North line of the right of way of the Minneapolis Northfield and Southern Railway; thence Southwesterly along said right of way line Three Hundred Thirty-one and nine-tenths (331.9) feet to the West line of the East one-half (1/2) of said Northwest Quarter (1/4); thence North Fourteen Hundred Seventy and six-tenths (1470.6) feet to point of beginning, including any portion of any street or alley adjacent thereto, vacated or to be vacated; together with Tract "A", Registered Land Survey Number 83, and the North 27 feet of Tract "K", Registered Land Survey Number 232.
