All that part of the South 26 rods of the West half of the Northwest Quarter of the Northwest Quarter (W 1/2 of NW 1/4 of NW 1/4) of Section Ten (10), Township Twenty-seven (27), Range Twenty-four (24) lying South of a line drawn parallel with the South line of said Northwest Quarter of the Northwest Quarter (NW 1/4 of NW 1/4) from a point on the West line of said Section Ten (10) distant 263 feet South of the Northwest corner of the South 26 rods of the Northwest Quarter of the Northwest Quarter (NW 1/4 of NW 1/4) of said Section Ten (10), except that part of the South 56 feet of the said Northwest Quarter of the Northwest Quarter (NW 1/4 of NW 1/4) lying East of the West 570 feet thereof; and the West 570 feet of the Southwest Quarter of the Northwest Quarter (SW 1/4 of NW 1/4) of Section Ten (10), Township Twenty-Seven (27), Range Twentyfour (24), lying North of a line drawn at right angles to the West line of the Southwest Quarter of the Northwest Quarter (SW 1/4 of NW 1/4) from a point on said West line distant 907.5 feet North of the Southwest corner of said Southwest Quarter of the Northwest Quarter (SW 1/4 of NW 1/4), the Easterly line of which has been determined in Torrens Case No. 9160.

That part of the East half (E 1/2) of the North 27 acres of the Northwest Quarter of the Northwest Quarter (NW 1/4 of NW 1/4) in Section Ten (10), Township Twenty-seven (27), Range Twenty-four (24) West, lying South of the North 655.8 feet except the East 25 feet thereof, Hennepin County, Minnesota.

That part of the South Twenty-six (26) rods of the East half of the Northwest Quarter of the Northwest Quarter (E 1/2 of NW 1/4 of NW 1/4) of Section Ten (10), Township Twenty-seven (27), Range Twenty-four (24), which lies North of the South 56 feet thereof, Hennepin County, Minnesota.
