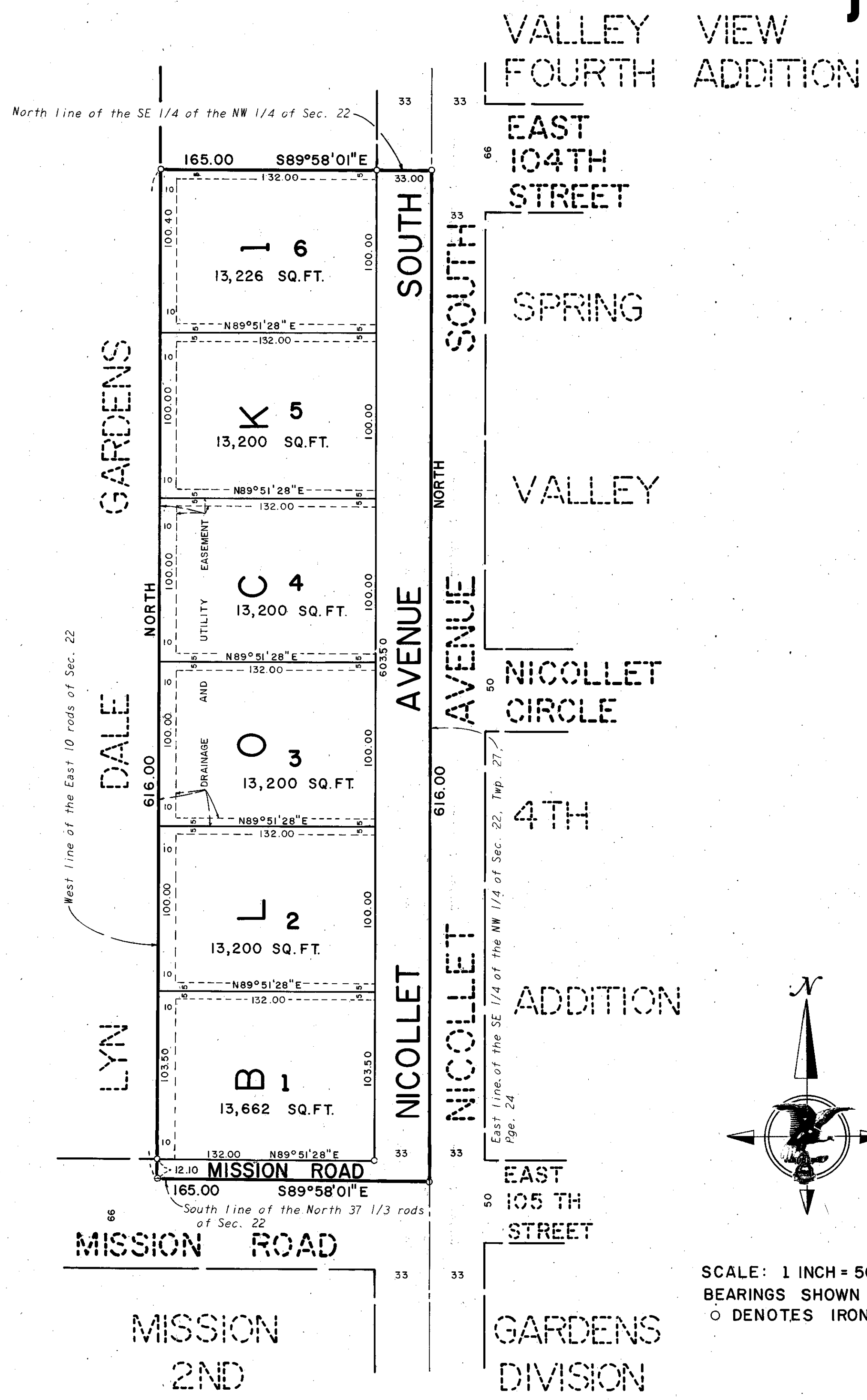


# J. P. RIEDEL & CO. 2ND ADDITION

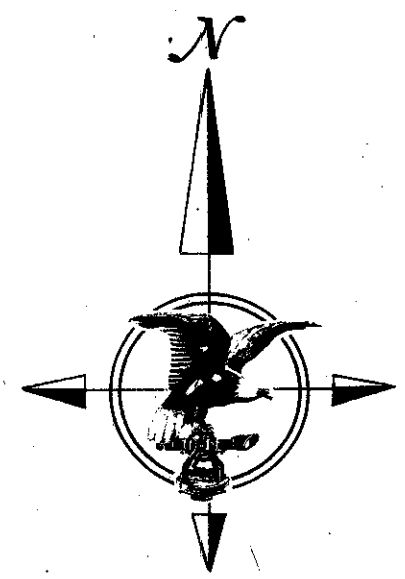
