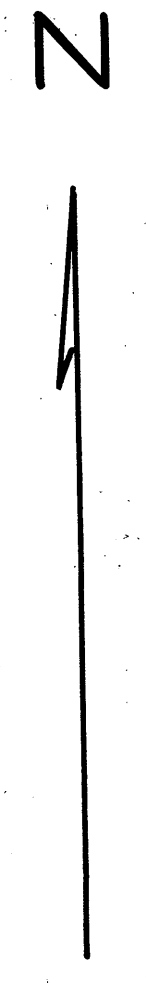
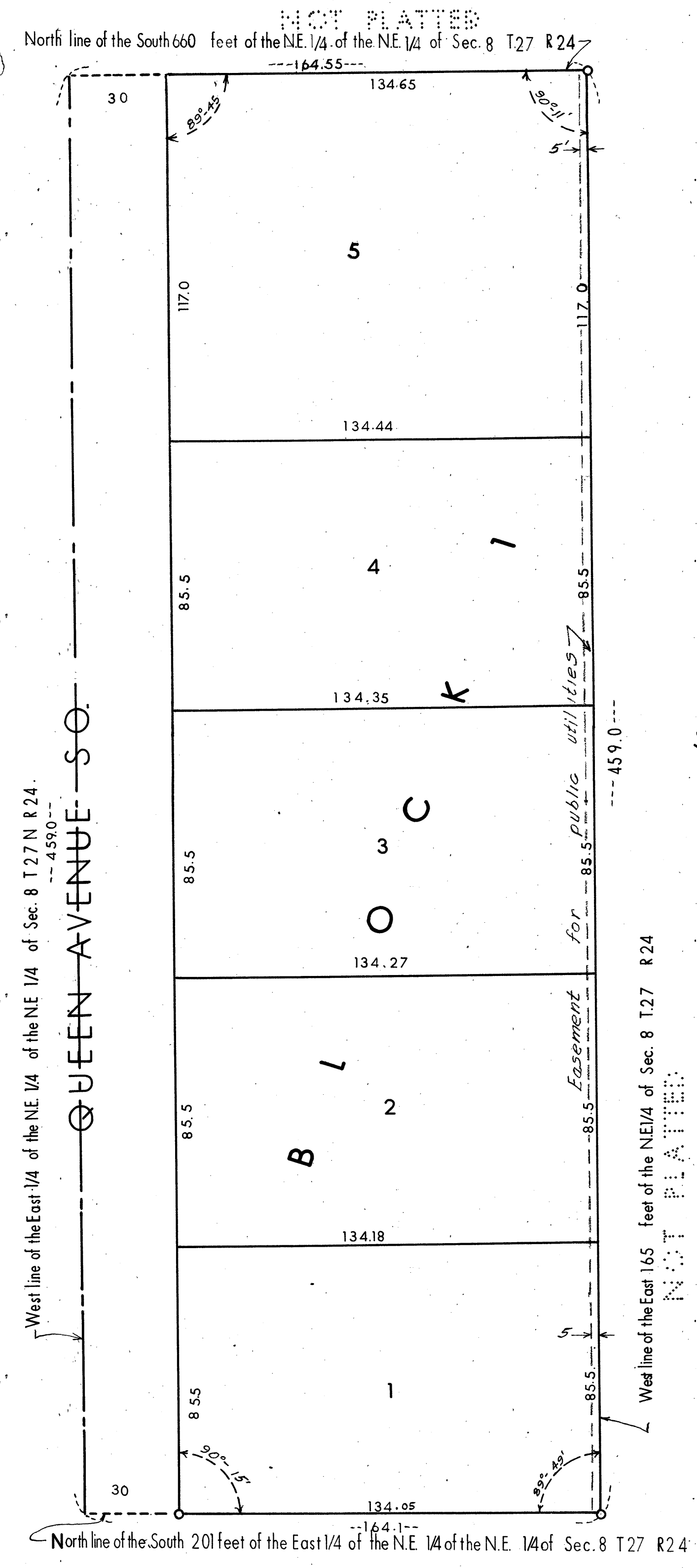


# JACOBSEN & QUIST 4TH ADD'N
