


JEFFREY LANE


HENNEPIN COUNTY, MINNESOTA

Know all men by these presents that we Francis F. Jeffrey and Lillian M. Jeffrey husband and wife owners and proprietors and Minneapolis Moline Credit Union a Minnesota corporation, Mortgagee, of the following described property situate in the State of Minnesota; County of Hennepin to wit: That part of the Southeast quarter of Section 15, Township 27, Range 24, described as follows: beginning on the East line of said Southeast quarter 642.4 feet South from the Northeast corner thereof, thence South along said East line 199 feet more or less to the North line of the Easterly portion of CRESTVIEW MANOR; thence West along said North line 657.75 feet to a point which is 84.6 feet South of the North line of said Southeast quarter; thence North along the boundary of said CRESTVIEW MANOR 199 feet; thence East 657.84 feet to the point of beginning. Have caused the same to be surveyed and platted as JEFFREY LANE and do hereby donate and dedicate to the public for public use forever, the place and avenue as shown on the annexed plat; also subject to easement for drainage and public utilities as shown on the annexed plat.
