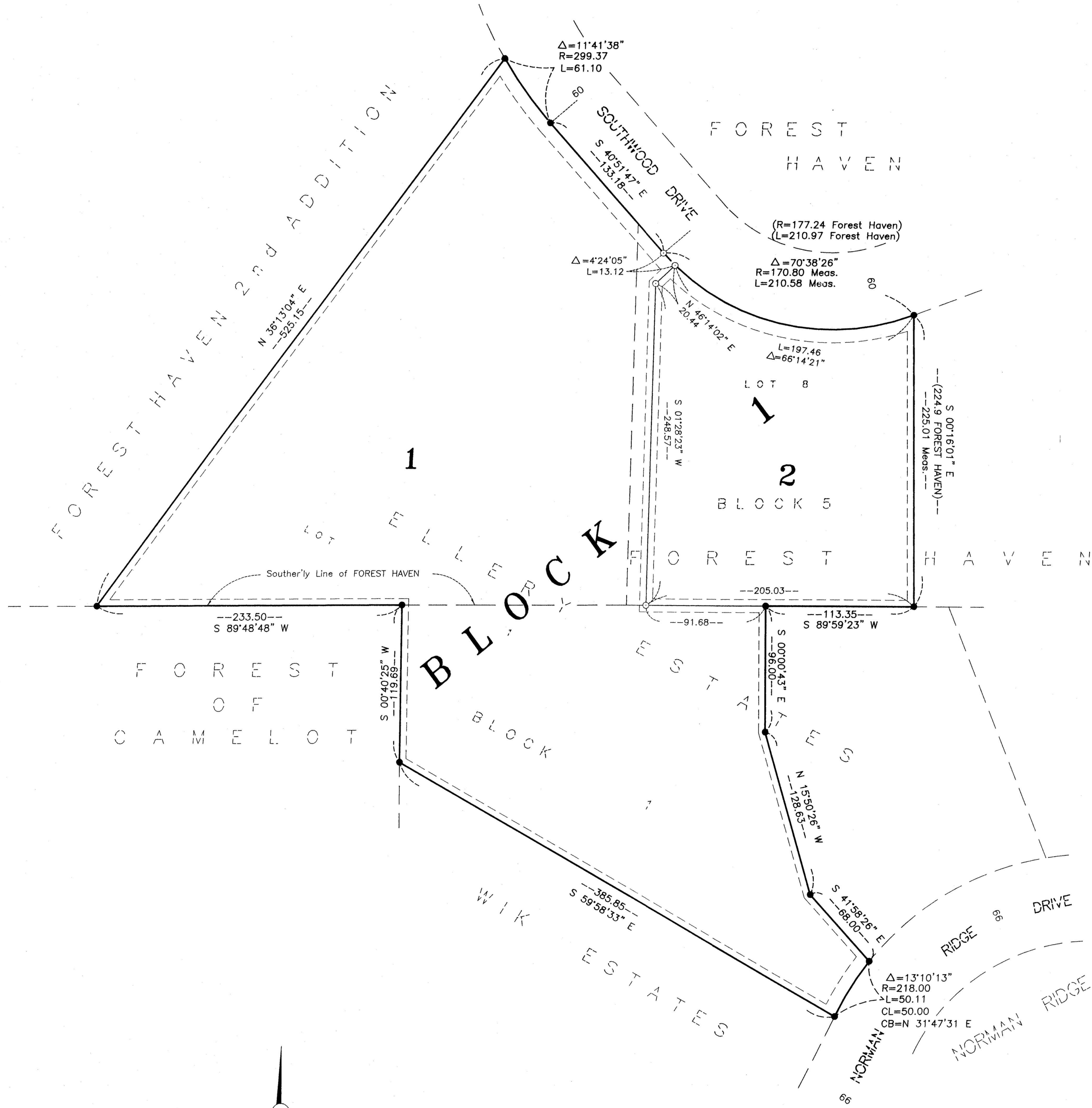

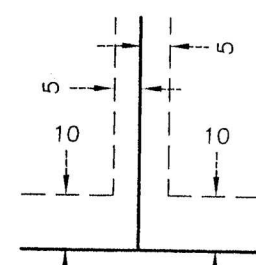

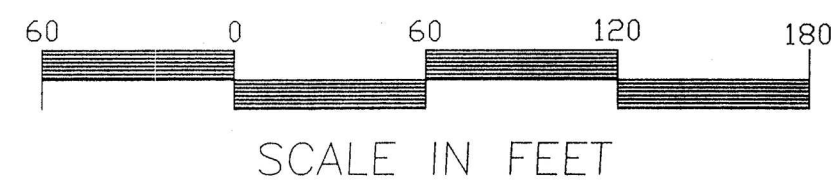
● Denotes Iron Monument Found
