From a point on the west line of said Section 6, distant 1079 feet south of the northwest corner thereof run westerly at an angle of 85°21' with said west section line (measured from north to west) for 245.2 feet to the point of beginning of the line to be described; thence run easterly along the last described course for 100 feet; thence deflect to the left on a 0°15' curve (delta angle 3°29') for 1393.3 feet; thence on tangent to said curve for 400 feet and there terminating; Document No. 739387;

And except that part of the first above described tract lying northwesterly of the following described line: Beginning at a point on the above described 165 foot parallel line distant 800 feet easterly of its intersection with a line run parallel with and distant 100 feet east of the west line of said Section 6; thence run southwesterly to a point on said 100 foot parallel line distant 535 feet southerly of said intersection, Document No. 739387;

And except that part of the first above described tract which lies northerly of a line run parallel with and distant 35 feet southerly of the following described line:

From a point on the west line of said Section 6, distant 1079 feet south of the northwest corner thereof run easterly at an angle of 85°21' with said west section line (when measured from south to east) for 1376.35 feet; thence deflect to the right at an angle of 1°52'30" for 375.03 feet; thence deflect to the right at an angle of 90° for 130 feet to the point of beginning of the line to be described; thence deflect to the right at an angle of 90° for 1000 feet and there terminating; Document No. 728355.


