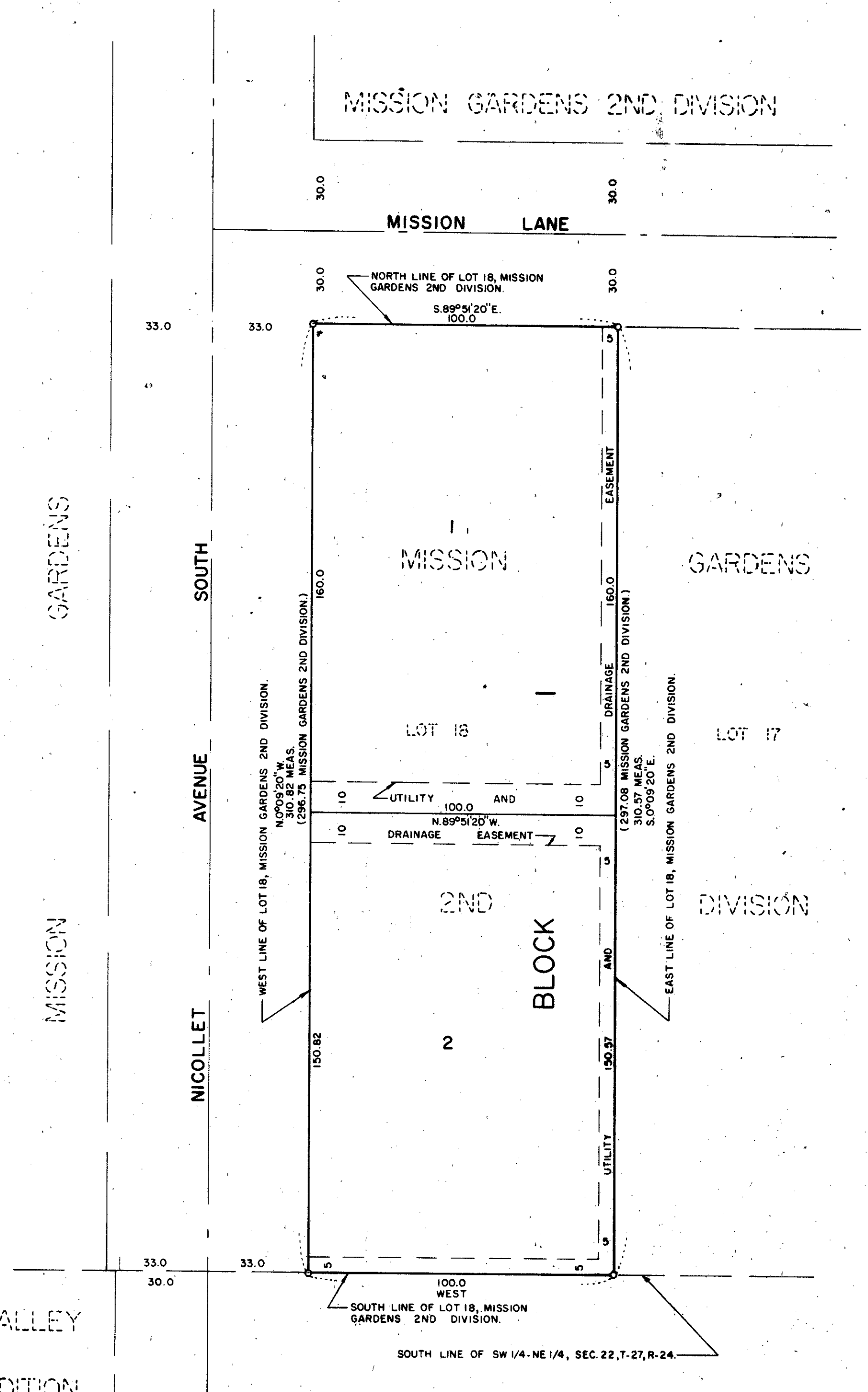


# MURIEL SAVAGE ADDITION
