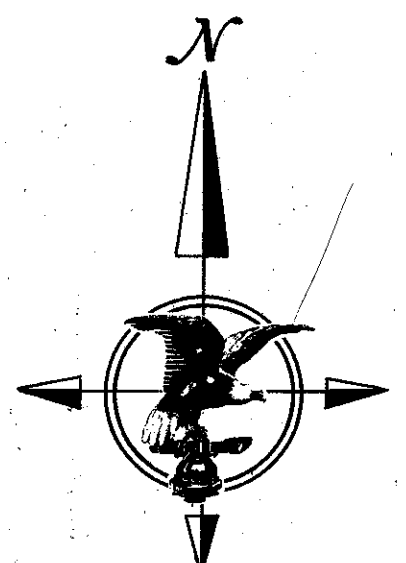
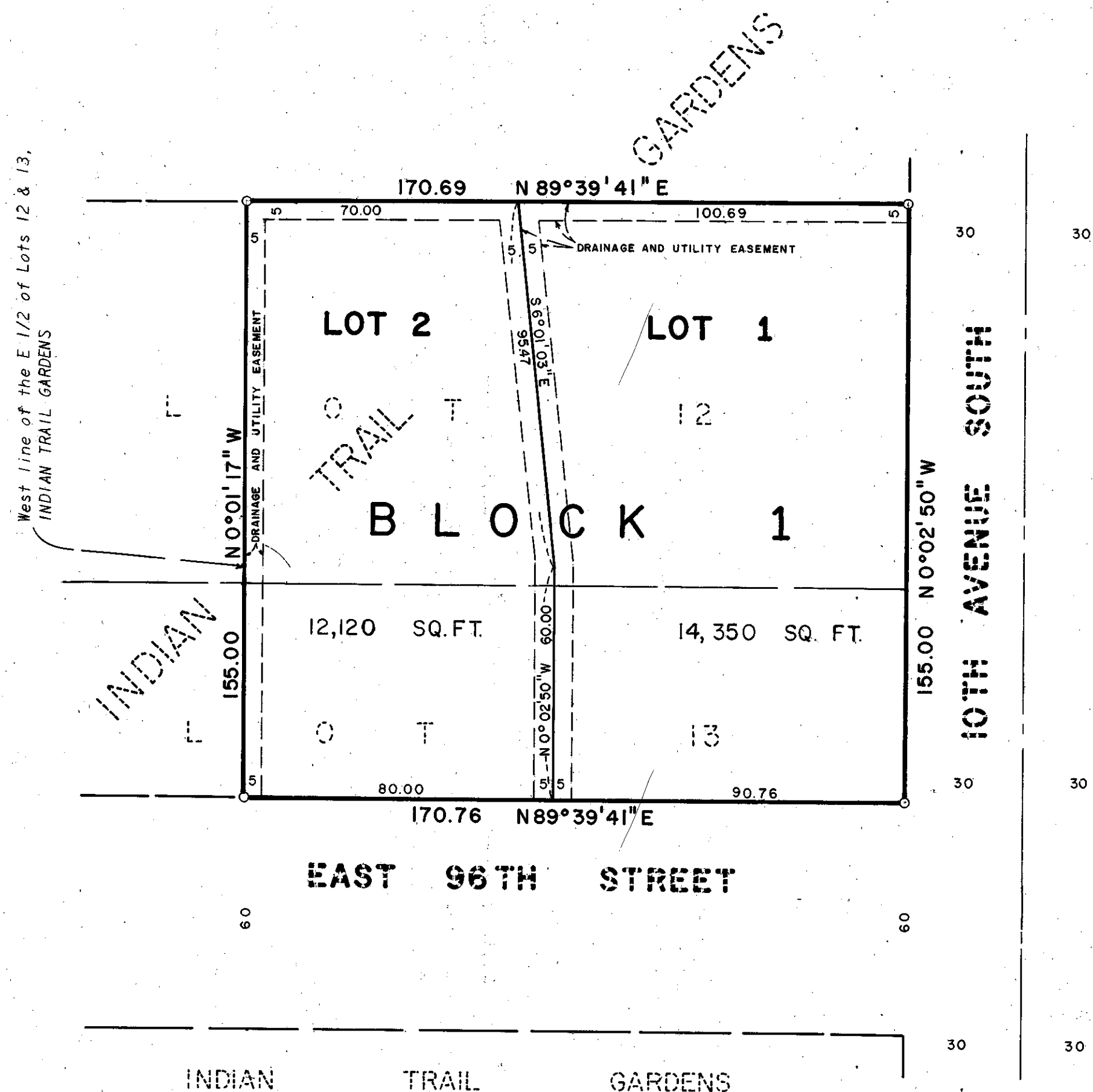


MYERS 1ST ADDITION
