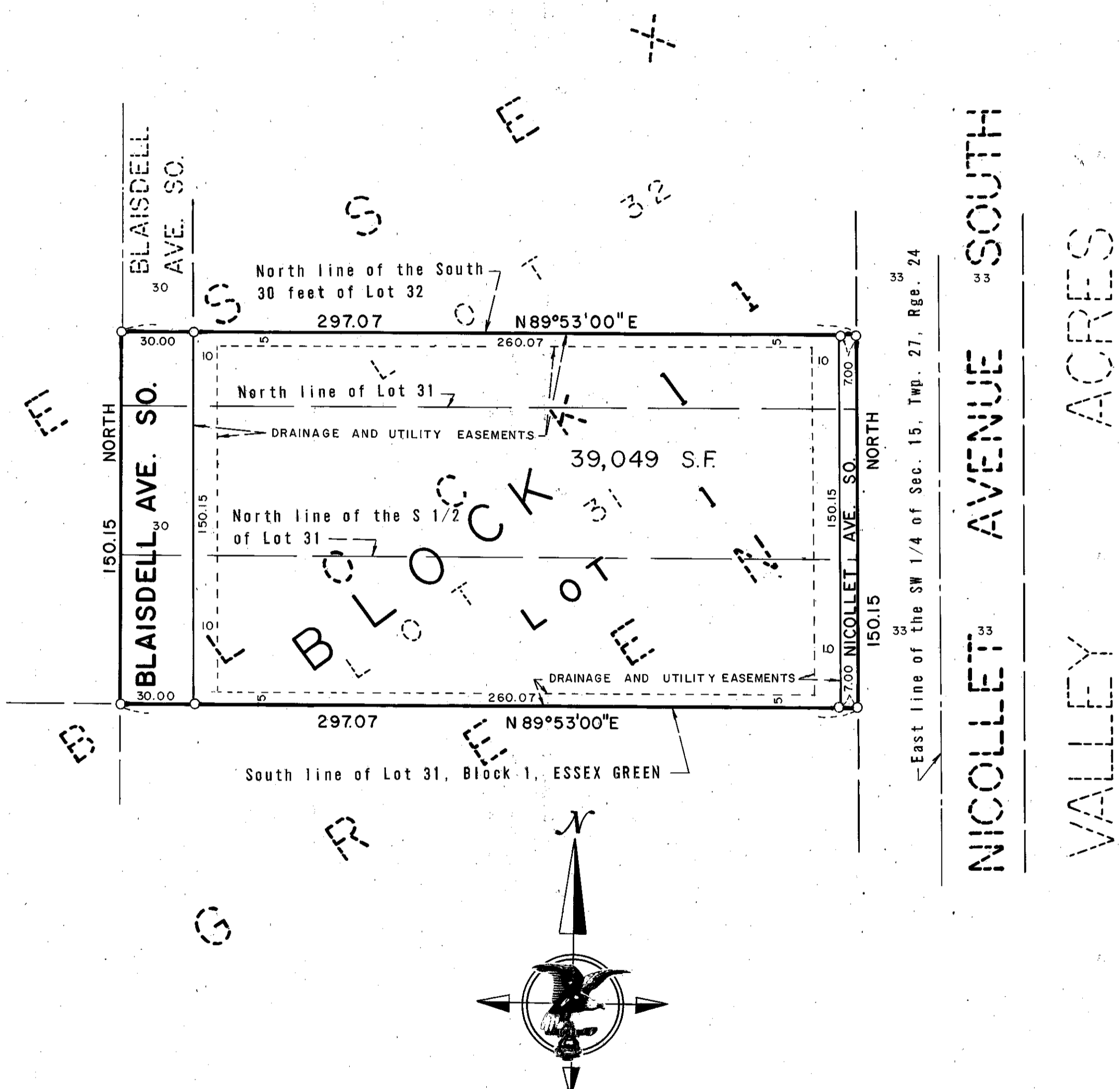


OREST 1ST ADDITION
