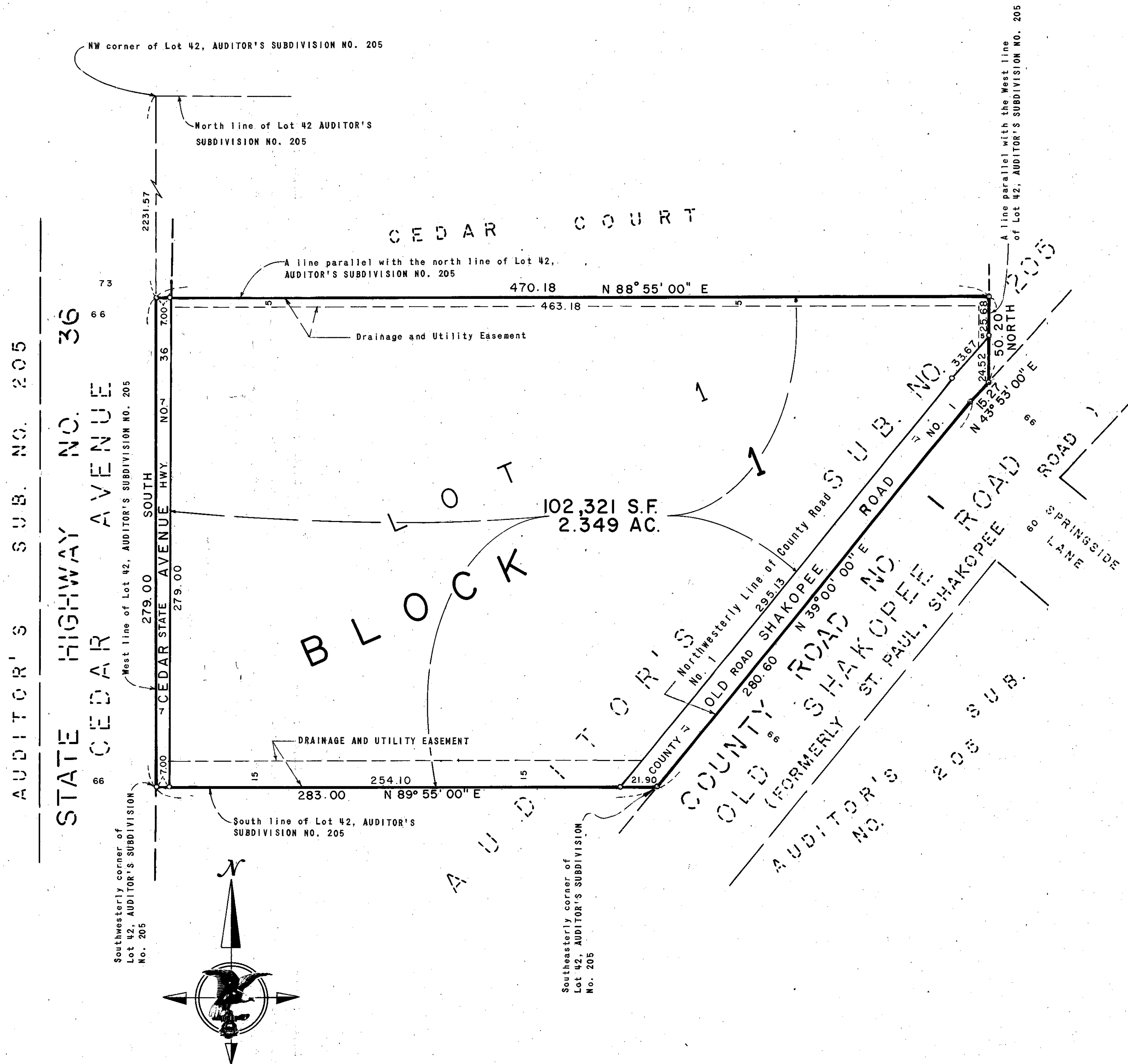


# OREST 2ND ADDITION



KNOW ALL MEN BY THESE PRESENTS: That Orest M Spande, single, owner and proprietor, of the following described Land, situate in the County of Hennepin, State of Minnesota, to wit:

All that part of Lot 42, AUDITOR'S SUBDIVISION NUMBER 205, Hennepin County, Minnesota, described as follows: Beginning at a point in the West line of said Lot 42, 2231.57 feet South of the Northwest corner thereof; thence East parallel with the North line of said Lot 42, 470.18 feet; thence South parallel with the west line of said Lot 42 to the Northwesterly line of St. Paul, Shakopee Road; thence Southwesterly along the Northwesterly line of St. Paul, Shakopee Road to the Southeasterly corner of said Lot 42; thence West along the South line of said Lot 42 to the Southwesterly corner thereof; thence North along the West line of said Lot 42, a distance of 279.0 feet to the point of beginning.

Has caused the same to be surveyed and platted as OREST 2ND ADDITION, and do hereby donate and dedicate to the public for public use forever the avenue, road and the drainage and utility easements as shown on the plat.

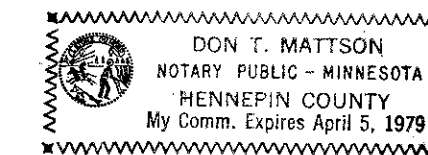

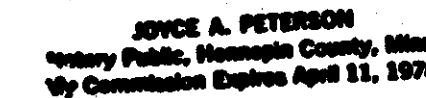
