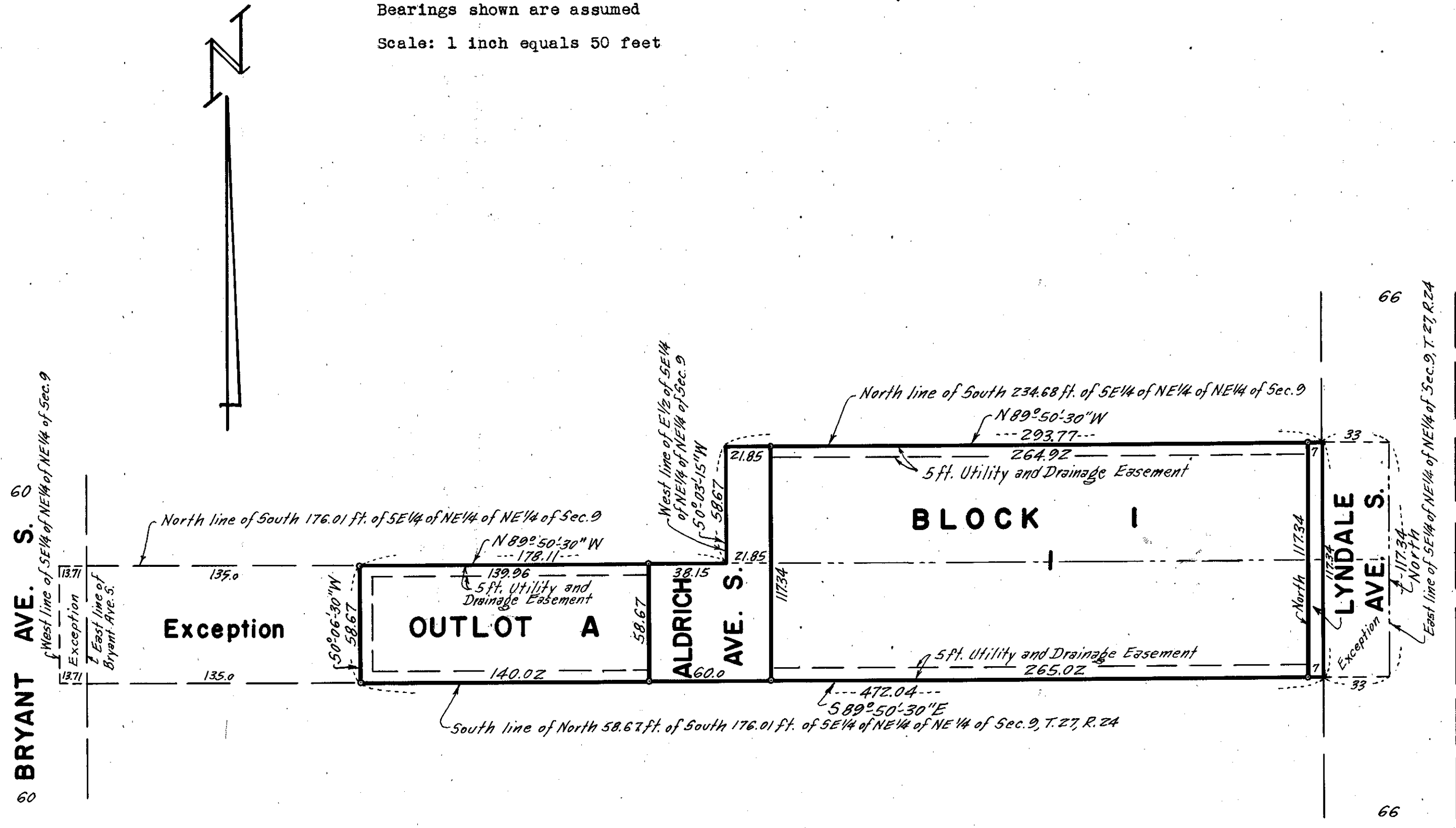


# PASTER'S ADDITION
