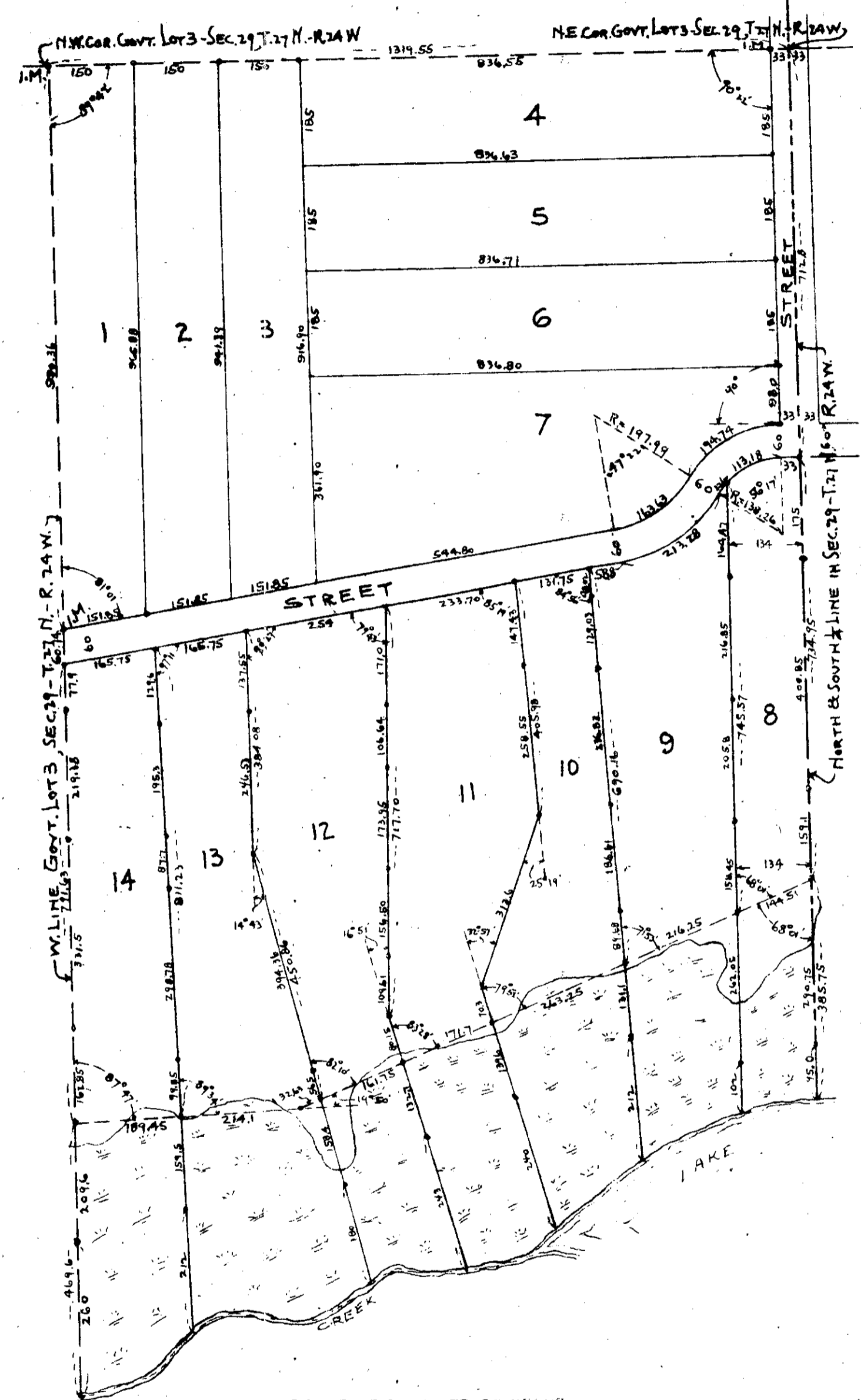


# QUESTEND

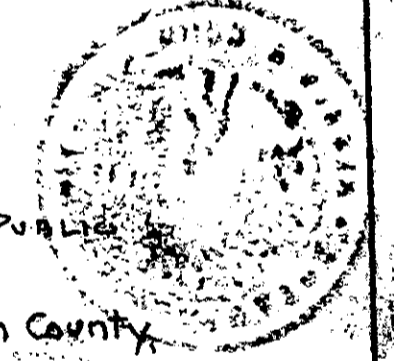

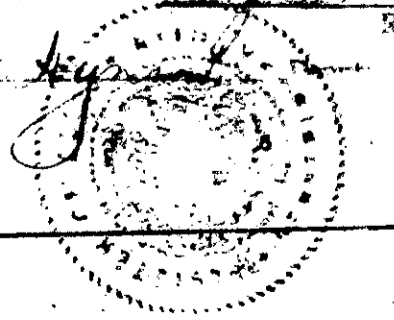
