I hereby certify that in accordance with the provisions of Chapter 508, Minnesota Statutes of 1949, as amended, I have surveyed the following described tract in the County of Hennepin, State of Minnesota, to wit:

The West Half of that part of the Southeast Quarter of the Northwest Quarter of Section 10, Township 27, Range 24, described as follows:

Beginning at a point on the West line of said Southeast Quarter of the Northwest Quarter 660 feet North from the Southwest corner of said Southeast Quarter of the Northwest Quarter; thence East parallel with the South line of said Southeast Quarter of the Northwest Quarter to the East line of said Southeast Quarter of the Northwest Quarter; thence North along said East line to its intersection with the North line of the South 56 rods of said Southeast Quarter of the Northwest Quarter; thence West along said North line to the West line of said Southeast Quarter of the Northwest Quarter; thence South along said West line to the point of beginning.

EXCEPT the North 100 feet of said West Half and

EXCEPT the East 190 feet of the South 82.5 feet of the North 182.5 feet of said West Half and

EXCEPT the South 52 feet of the West 100 feet of the East 330 feet of said West Half and

EXCEPT the West 240 feet of the South 126 feet of the North 226 feet of said West Half and

EXCEPT the West 260 feet of the South 38 feet of said West Half and

EXCEPT the East 20 feet of the West 260 feet of the South 22 feet of the North 226 feet of said West Half and

EXCEPT the South 104 feet of the North 204 feet lying East of the West 240 feet of said West Half and West of the East 190 feet of said West Half.

That part of the Southeast Quarter of the Northwest Quarter, Section 10, Township 27, Range 24, described as beginning at a point on the West line of said Southeast Quarter of the Northwest Quarter distant 396 feet North from the Southwest corner of said Southeast Quarter of the Northwest Quarter; thence North along said West line 264 feet; thence East, parallel with the South line of said Southeast Quarter of the Northwest Quarter, a distance of 260 feet; thence South, parallel with said West line, a distance of 264 feet; thence West, parallel with said South line, a distance of 260 feet to the point of beginning, according to the Government Survey thereof.

That part of the Southeast Quarter of the Northwest Quarter, Section 10, Township 27, Range 24, described as commencing at a point on the West line of said Southeast Quarter of the Northwest Quarter distant 660 feet North from the Southwest corner of said Southeast Quarter of the Northwest Quarter; thence East, parallel with the South line of said Southeast Quarter of the Northwest Quarter, a distance of 260 feet to the point of beginning; thence continuing East along said parallel line 400 feet; thence South, parallel with said West line, a distance of 264 feet; thence West, parallel with said South line, a distance of 400 feet; thence North, parallel with said West line, a distance of 264 feet to the point of beginning, according to the Government Survey thereof.

The West 260 feet of the South 60 feet of the West Half of that part of the Southeast Quarter of the Northwest Quarter of Section 10, Township 27, Range 24, described as follows:

Beginning at a point on the West line of said Southeast Quarter of the Northwest Quarter 660 feet North from the Southwest corner of said Southeast Quarter of the Northwest Quarter; thence East, parallel with the South line of said Southeast Quarter of the Northwest Quarter to the East line of said Southeast Quarter of the Northwest Quarter; thence North along said East line to its intersection with the North line of the South 56 rods of said Southeast Quarter of the Northwest Quarter; thence West along said North line to the West line of said Southeast Quarter of the Northwest Quarter; thence South along said West line to the point of beginning.

The West 240 feet of the South 104 feet of the North 204 feet of that part of the Southeast Quarter of the Northwest Quarter of Section 10, Township 27, Range 24, according to the government survey thereof, bounded as follows:

Beginning at a point on the West line of said Southeast Quarter of the Northwest Quarter 660 feet North from the Southwest corner of said Southeast Quarter of the Northwest Quarter; thence East, parallel with the South line of said Southeast Quarter of the Northwest Quarter to the East line of said Southeast Quarter of the Northwest Quarter; thence North along said East line to its intersection with the North line of the South 56 rods of said Southeast Quarter of the Northwest Quarter; thence West along said North line to the West line of said Southeast Quarter of the Northwest Quarter; thence South along said West line to the point of beginning.

That part of the West 1/2 of the Southeast 1/4 of the Northwest 1/4 of Section 10, Township 27, Range 24, lying North of the South 56 rods of said Quarter-Quarter and lying Southerly of a line drawn from a point in the West line of said Southeast 1/4 of the Northwest 1/4 distant 0.23 feet North of the Northwest corner of said South 56 rods of said Quarter-Quarter section to a point in the North line of said South 56 rods, a distant 164 feet East of the Northwest corner of said South 56 rods.

The North 100 feet of the West Half of that part of the Southeast Quarter of the Northwest Quarter of Section 10, Township 27, Range 24, described as follows:

Beginning at a point on the West line of said Southeast Quarter of the Northwest Quarter 660 feet North from the Southwest corner of said Southeast Quarter of the Northwest Quarter; thence East, parallel with the South line of said Southeast Quarter of the Northwest Quarter to the East line of said Southeast Quarter of the Northwest Quarter; thence North along said East line to its intersection with the North line of the South 56 rods of said Southeast Quarter of the Northwest Quarter; thence West along said North line to the West line of said Southeast Quarter of the Northwest Quarter; thence South along said West line to the point of beginning.

EXCEPT the East 190 feet of said West Half.

The South 104 feet of the North 204 feet of the West Half of that part of the Southeast Quarter of the Northwest Quarter of Section 10, Township 27, Range 24, described as follows:

Beginning at a point on the West line of said Southeast Quarter of the Northwest Quarter 660 feet North from the Southwest corner of said Southeast Quarter of the Northwest Quarter; thence East, parallel with the South line of said Southeast Quarter of the Northwest Quarter to the East line of said Southeast Quarter of the Northwest Quarter; thence North along said East line to its intersection with the North line of the South 56 rods of said Southeast Quarter of the Northwest Quarter; thence West along said North line to the West line of said Southeast Quarter of the Northwest Quarter; thence South along said West line to the point of beginning.

EXCEPT the East 190 feet of the South 104 feet of the North 204 feet of said West Half and

EXCEPT the West 204 feet of the South 104 feet of the North 204 feet of said West Half.
