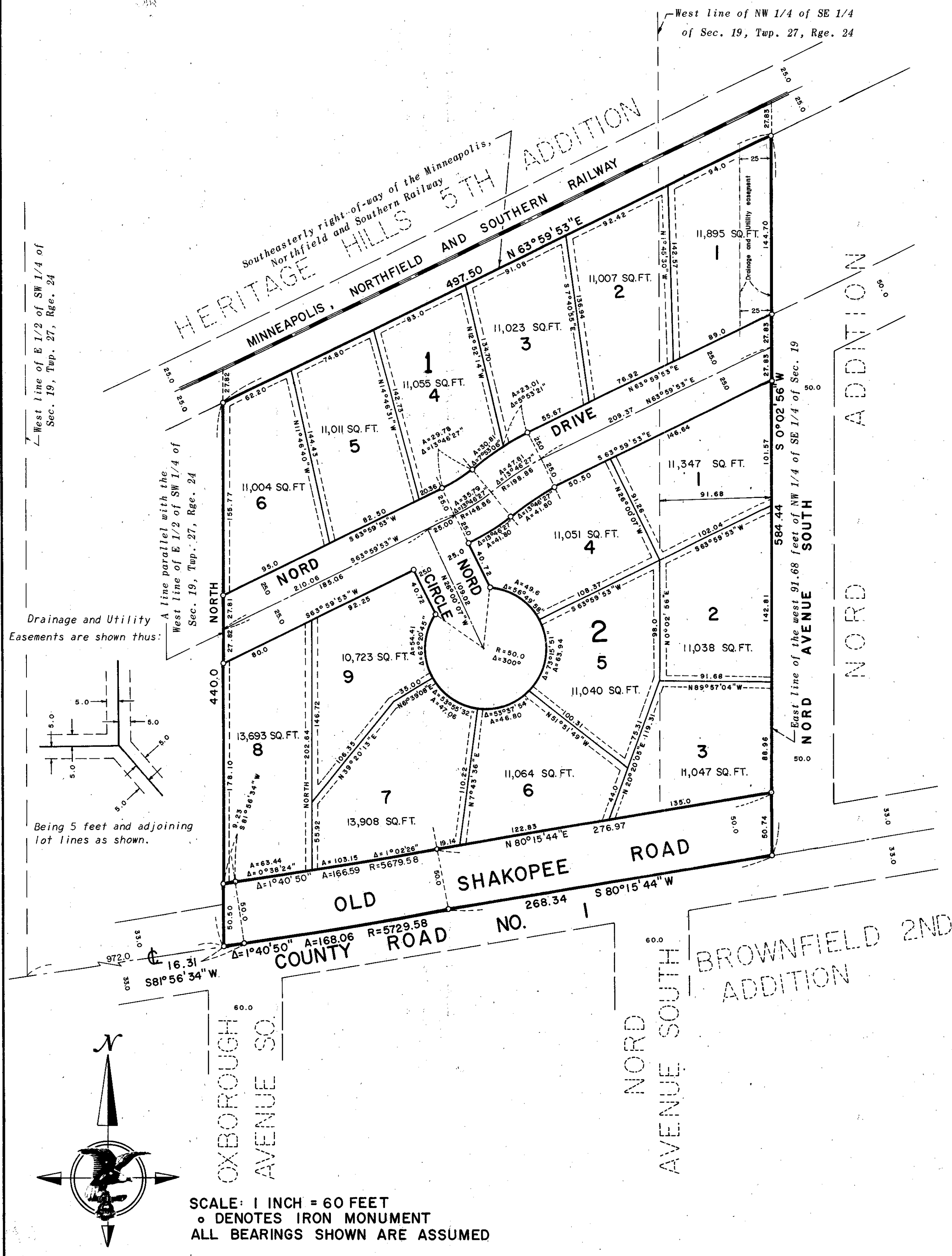


REZAC - WILL 4TH ADDITION

That part of the East Half of the Southwest Quarter of Section 19, Township 27, Range 24, lying north of the centerline of County Road No. 1 and south of the southeasterly line of the right-of-way of the Minneapolis, Northfield and Southern Railway Company and east of a line running parallel to the west line of said East Half of the Southwest Quarter from a point on the centerline of said County Road distant 972 feet easterly from said west line measured along the centerline of said County Road.

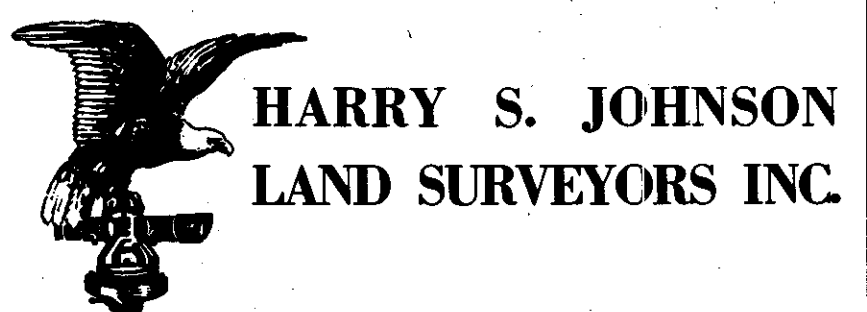
