In witness whereof said Robert E. Daly has hereunto set his hand this 13th day of January 1975.

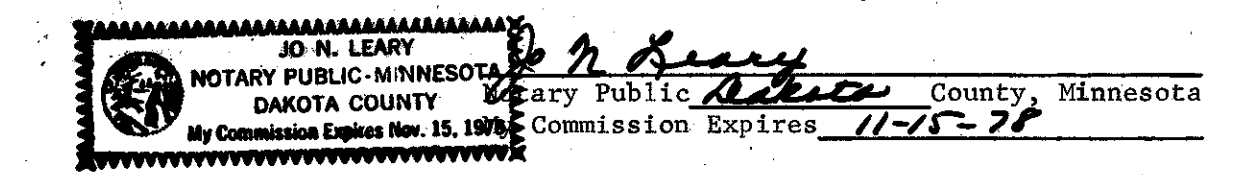
