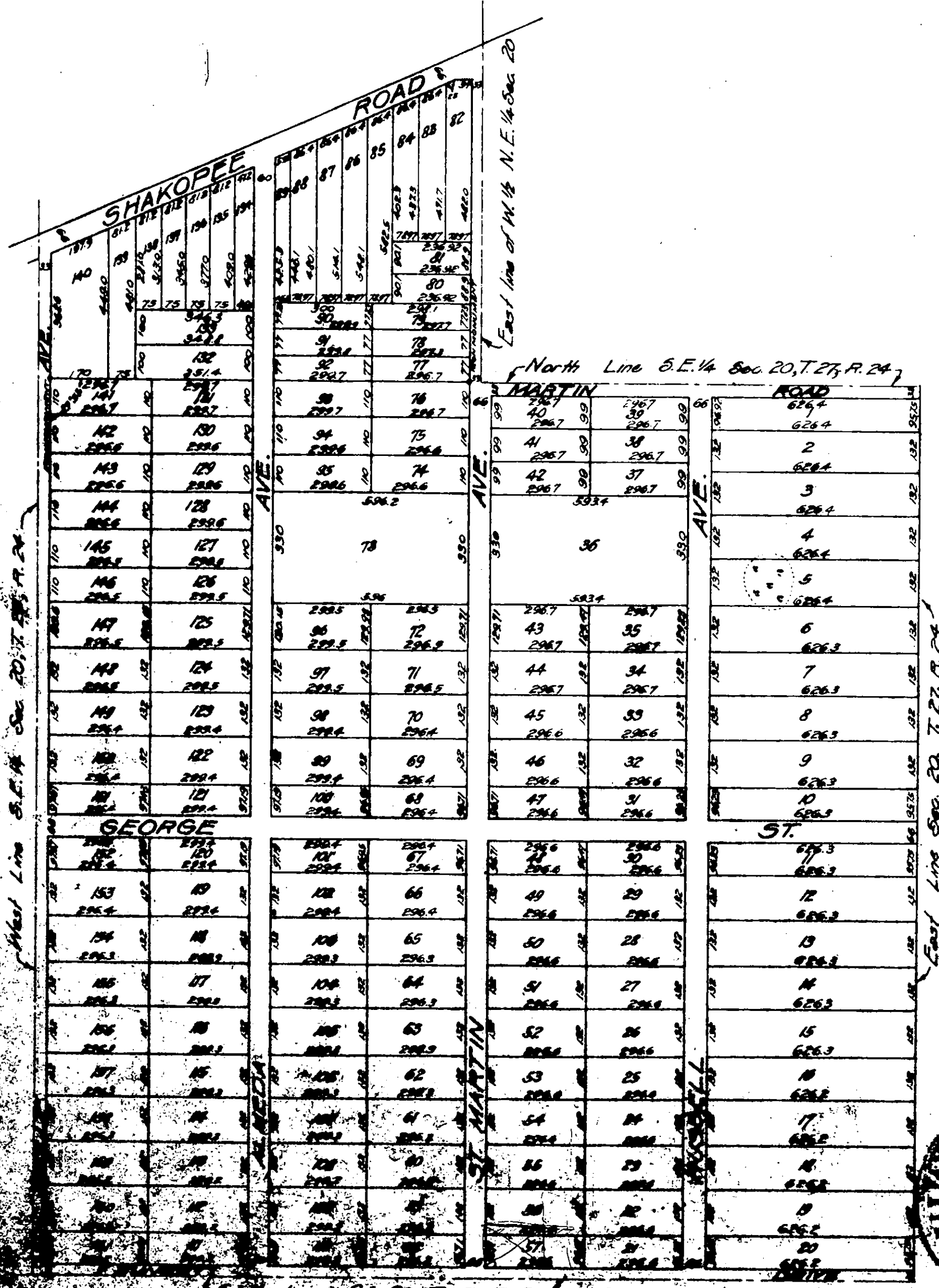
ST. MARTIN'S WALESWOOD ADDITION

Baillif assignee of mortgage of the following described property to-wit: All of the Southeast Quarter of Section Twenty (20), Township Twenty-seven (27) North, Range Twenty-four (24), West of the Fourth Principal Meridian, and all that part of the West One-half (W 1/2) of the Northeast Quarter (N.E. 1/4) of Section Twenty (20), Township Twenty-seven (27), Range Twenty-four (24), lying South of the Shakopee Road, so called, have caused the same to be surveyed and platted as ST.
